It was signed by the Government of India, the Assam Government, and Bodo organizations, including the National Democratic Front of Bodoland (NDFB). Bodoland Territorial Council (BTC) was renamed BTR with greater autonomy. Non-Bodo villages in BTC were excluded. BTC's powers were expanded under the Sixth Schedule. Bodo was recognized as an associate official language of Assam.

Menhirs vary in size, shape, and arrangement, including circles, semicircles, and parallel rows. The Carnac Stones in France, with 2,935 menhirs, is the most famous alignment. Some menhirs have engravings linked to fertility rites and seasonal cycles. Megaliths are stone structures used as burial sites or memorials.
