The Union Minister of Ports, Shipping & Waterways launched the One Nation-One Port Process (ONOP). ONOP aims to standardize port operations across India's major ports. The initiative removes inconsistencies in documentation, reduces inefficiencies, lowers costs, and minimizes delays. The Ministry reduced container operation documents by 33%, from 143 to 96. Bulk cargo documents were cut by 29%, from 150 to 106.

Kailash Satyarthi, born in 1954 in Madhya Pradesh, has led global efforts against child slavery and exploitation in 140 countries. His organization has rescued over 1,38,000 children from child labour and trafficking. He highlighted that compassion is the key to solving global issues.

The Harpoon (RGM-84/UGM-84/AGM-84) is a subsonic anti-ship cruise missile developed by Boeing for the U.S. Navy. Introduced in 1977, it is used by over 30 countries, including India. It has a range of 90-240 km and can be launched from ships, submarines, shore batteries, and aircraft.

**4.Which team won the Ranji Trophy 2024-25?**

A US Marine Corps (USMC) F-35B Lightning II recently conducted its first test missions with the Meteor air-to-air missile. Meteor is a radar-guided, beyond-visual-range air-to-air missile (BVRAAM) developed by MBDA for six European nations (UK, Germany, Italy, France, Spain, Sweden). It has a ramjet engine, enabling controlled flight speed, complex maneuvers, and a range of over 100 km. It flies at Mach 4+ with a large no-escape zone.
