The National River Traffic and Navigation System (NRT&NS) was launched on January 11, 2025, by the Union Minister of Ports, Shipping, and Waterways. National River Traffic and Navigation System aims to ensure safe and efficient operation of inland vessels.

The launch took place during the 2nd meeting of the Inland Waterways Development Council (IWDC). IWDC, established in 2023, serves as an apex platform for policy discussions to promote inland waterways in India.
