It includes 12 compartments from Paund and Sinhgad ranges in Pune division and 8 compartments from Mangaon range in Roha division of Thane.

Planarians are aquatic flatworms known for their amazing ability to regenerate lost body parts. This species was found in a wetland within the Western Ghats, which is a biodiversity hotspot. The discovery marks the first time since 1983 that a new planarian species has been identified in India. *Dugesia punensis* adds to the understanding of India's freshwater biodiversity and highlights the ecological importance of urban wetlands like Pashan Lake.

The Spratly Islands are claimed entirely by China, Taiwan, and Vietnam, and partially by Malaysia and the Philippines. Thitu is the second largest natural island in the Spratlys and the biggest of the nine occupied by the Philippines.

India's Maternal Mortality Ratio (MMR) has reduced from 130 in 2014–16 to 80 in 2021–23, showing strong impact.
