The portal acts as a one-stop platform for farmers, entrepreneurs and industries. It provides easy access to Central and State Government schemes in the agriculture sector. Currently, it gives information on 17 key schemes like Agriculture Infrastructure Fund and Animal Husbandry Infrastructure Development Fund.

Nalsarovar Bird Sanctuary is located in Gujarat. It was declared a sanctuary in 1969 and became a Ramsar Site in 2012 under the Ramsar Convention. It hosts 48 algae and 72 flowering plant species, supporting rich birdlife and biodiversity.

It is designed for Intelligence, Surveillance, Reconnaissance (ISR) and precision strike missions. It is Turkey's first armed UAV developed domestically, showcasing its defence manufacturing capabilities.

Department of Land Resources (DoLR) under the Ministry of Rural Development. The programme prepares detailed maps of towns and cities to improve land records.
