The portal improves efficiency and transparency in Provident Fund and Pension services for coal sector workers. It enables real-time tracking of claims, automatic ledger updates, and direct transfers to workers' accounts.

India's high-net-worth individual (HNWI) wealth rose by 8.8 percent, with strong gains in the "millionaires next door" segment. India had 333,340 millionaires next door and 4,290 ultra-high-net-worth individuals (UHNWIs) in 2024. The report covers 71 countries and highlights U.S. leadership in wealth growth, while India and Japan led in Asia-Pacific.

Menar is a freshwater monsoon wetland formed by Braham talab, Dhand talab, Kheroda talab, and nearby farmland that floods during monsoon. It supports water birds like the critically endangered white-rumped vulture and long-billed vulture. Khichan in the Thar Desert includes Ratri river and Vijaysagar pond, and supports 150 bird species.

ECOSOC was established in 1945 under the UN Charter and is one of the six main organs of the United Nations. It is headquartered in New York, United States.
