The Sindoor plant, scientifically known as *Bixa orellana*, is a small tropical shrub famous for its bright red seeds. It is commonly called 'Annatto' in English and Sindoor plant in Hindi. It is generally found in tropical regions of Central America. It grows well in most soils, preferring neutral to slightly alkaline types.
