Revise jigl from 19 – 1st paper makes or breaks confidence so prepare well

(as you have already done multiple revisions now it will be easier and also you have to cover whole syllabus within 1 day before exams so in this phase you will get an idea how you will study day before exams)

I HAVE REDUCED 1 DAY FOR EACH SUBJECTS IN EACH PHASE JUST BECAUSE YOU ALL SHOULD GET A HABIT TO COVER EVERYTHING IN FEW DAYS AS YOU WILL GET LESS THAN A DAY BEFORE EXAMS TO COVER ENTIRE SYLLABUS

POINTS TO BE NOTED :

- MAKE COMBINATION OF ONE VERY LENGTHY CHP and 3 SHORT AND EASY CHPS and complete it within a day
- Eg : In jigl – constitution , contract , negotiable , BNS and all these are very lengthy chps – pick **one** of these and combine it with easy chps like RTI ACT , IT ACT , ADMINISTRATIVE etc
- Aise you can complete 4 chps in a day
- 1st REVISION WILL TAKE TIME – DO NOT PANIC (sabko time lagta hai 1st revision mai with multiple revision everything gets concised)
- PRACTICE PRACTICAL SUB DAILY (practical subject se masti nahi please)
- DO NOT TO DO SELECTIVE STUDY YOU WILL NOT BE ABLE TO ATTEMPT FULL PAPER ...PLEASE COVER FULL SYLLABUS.
- PLEASE SOLVE MODULE ILLUSTRATIONS FOR LAWS. (sometimes same ques comes in exams with similar facts)

ANS PRESENTATION

- Please follow proper format for case based questions - provision facts & conclusions paper consists mostly of case based ques pls present your ans well.. Provision and conclusion if you'll write with clarity and cover all the points you can get 3-4 marks
- Start your provision with - "in pursuance of relevant section... And rules made thereunder
- Don't waste much of your time on facts write key points of ques in few lines
- Conclusion -" keeping in view the provision and facts of the case..." Then start writing conclusion from next line .. If you lack time simply write "in conclusion of above" Or "thereby concluding"
- Don't directly write paras.. Give proper heading "provision facts conclusion" Then write your ans in paras & pointers leave line after writing paras.. Don't write in continuation it looks shabby.
- Cover all points in provision and conclusion.. Be lil elaborative in your conclusion.. Explain it acche se don't just write the conclusion in 2 lines and finish it off.. Properly explain it "ye karna tha ye nhi kiya isliye aisa hai" aise proper explanation do phle phir write "thereby concluding..."

- For direct question pls always start with brief introduction about the topic don't rush to write pointers and finish it off.. Give proper introduction explain the topic in 3-4 lines then start with your ans ...write at least 8 points for direct question

Then give a conclusion line by stating " The aforementioned points... " Or whatever

- Present your ans well..frame proper sentences
- For jig1 pls quote legal maxims
- Avoid using short forms ... Attempt full paper pls for that avoid selective study cover full portion
- Start new ques on new page.. In the middle of your page properly quote "Answer to Q. No _ "
- Quantity of ans doesn't matter quality does.. Be specific and precise in provision & conclusion
- If you don't know any ans write few relevant points and leave it instead of getting zero you'll at least get 1 marks
