1. Mr. X acquires an asset in the year 2016-17 for the use for scientific research for ₹ 2,75,000. He claimed deduction under section 35(1)(iv) in the previous year 2016-17. The asset was brought into use for the business of Mr. X in the P.Y.2025-26, after the research was completed. The actual cost of the asset to be included in the block of assets is -
 - (a) Nil
 - (b) Market value of the asset on the date of transfer to business
 - (c) ₹ 2,75,000 less notional depreciation under section 32 upto the date of transfer.
 - (d) Actual cost of the asset i.e., ₹ 2,75,000
2. The W.D.V. of a block (Plant and Machinery, rate of depreciation 15%) as on 1.4.2025 is ₹ 3,20,000. A second hand machinery costing ₹ 50,000 was acquired on 1.9.2025 through account payee cheque but put to use on 1.11.2025. During January 2025, part of this block was sold for ₹ 2,00,000. The depreciation for A.Y.2026-27 would be -
 - (a) ₹ 21,750

3. An electricity company charging depreciation on straight line method on each asset separately, sells one of its machinery in April, 2025 at ₹ 1,20,000. The WDV of the machinery at the beginning of the year i.e., on 1st April, 2025 is ₹ 1,35,000. No new machinery was purchased during the year. The short fall of ₹ 15,000 is treated as -
 - (a) Short-term capital loss
 - (b) Normal depreciation
 - (c) Terminal depreciation
 - (d) Any of the above, at the option of the assessee
4. Mr. Raja, a proprietor, commenced operation of the business of a new three star hotel in Mumbai on 1.7.2025. He had made a total investment of Rs. 7.58 crores till 30.6.2025. Out of total investment of Rs. 7.58 crores, Rs. 1.58 crores was used for purchase of land in P.Y.2024-25. Rs. 4.70 crores was used for constructing Hotel and balance of Rs. 1.30 used for purchasing the furniture in P.Y. 2025-26. He wants to avail the benefit of deduction u/s 35AD as he satisfied with all the conditions prescribed u/s 35AD and has exercised the option of shifting out of the default regime provided u/s 115BAC(1A). His profit

and gains from the business for P.Y. 2025-26 is Rs. 50 lakhs before claiming deduction u/s 35AD. He wants to file his income-tax return on 12.12.2026. How much deduction Mr. Raja can claim for A.Y. 2026-27 and the losses which he can carry forward to A.Y. 2027-28?

- (a) He can claim the deduction of Rs. 7.58 crores from his business income but he would not be able to carry forward the business loss of Rs. 7.08 crores
 - (b) He can claim the deduction of Rs. 6.00 crores from his business income and can carry forward the business loss of Rs. 5.50

Case scenario

ABC & Co is a partnership firm engaged in the business of sale of footwear. The partnership firm consist of three partners - A, B & C. A & B are working partners, and C is a sleeping partner. The firm is liable to tax audit u/s 44AB of the Act. It has a book profit of Rs. 11,50,000.

Following payments were made to partners as authorised by the partnership deed:

- Remuneration to A & B - Rs. 32,000 p.m. to each partner
- Remuneration to C - Rs. 10,000 p. m.
- Interest on capital@ 19.5% to A & B - Rs. 18,500 p.a. to each partner
- Interest on capital @ 17% to C- Rs. 10,540 p.a.

The firm has following brought forward losses of past years:

Case Scenario

Mr. Naveen, aged 40 years, is engaged in the manufacturing business. He follows mercantile system of accounting. The details pertaining to his business for the year ending on 31.3.2026 is as under –

An analysis of profit and loss for the year ended on 31.3.2026 revealed the following information

- Salary includes wages of ₹ 15,000 p.m. each paid to 1 security guard, 2 housekeeping staff in cash.
- Other administration expenses include ₹ 70,000 paid in cash (Payment in a day is less than ₹ 8,000).
- Interest charges includes interest payable on loan to Kamal of ₹ 70,000 on which TDS has not been deducted. Loan was taken for the business purpose.

Question: 9

Is Mr. Naveen eligible to declare income on presumptive basis under the provisions of the Income-tax Act, 1961 for A.Y. 2026-27?

1. Mr. Venus., engaged in manufacture of pesticides, furnishes the following particulars relating to its manufacturing unit at Chennai, for the year ending 31-3-2026:

WDV of Plant and Machinery on 31.3.2025	30
Depreciation including additional depreciation for P.Y. 2024-25	4.75
New machinery purchased on 1-9-2025	10
New machinery purchased on 1-12-2025	8
Computer purchased on 3-1-2026	4

Additional information:

- All assets were purchased by A/c payee cheque.
- All assets were put to use immediately.
- New machinery purchased on 1-12-2025 and computer have been installed in the office.
- During the year ended 31-3-2025, a new machinery had been purchased on 31-10-2023, for ₹ 10 lacs. Additional depreciation, besides normal depreciation, had been claimed thereon.
- Depreciation rate for machinery may be taken as 15%.

Compute the depreciation available to the assessee as per the provisions of the Income-tax Act, 1961 and the WDV of different blocks of assets as on 31-3-2026. Assume that he does not opt for section 115BAC. **[7 Marks]**

2. Mr. Yogesh is in the business of operating goods vehicles. As on 1st April, 2025, he had the following vehicles:

3. Dr. Arjun runs a clinic in Delhi. As per new rule in the city, private cars can be plied in the city only on alternate days. He has purchased a car on 25-09-2025, for the purpose of his medical profession, as per following details:

Cost of car (excluding GST)	15,00,000
Add: Delhi GST at 14%	2,10,000
Add: Central GST at 14%	2,10,000
Total price of car	19,20,000

He put his car to use from 25.9.2025 itself. He estimates the usage of the car for personal purposes will be 25%. He is advised by his friends that since the car has run only on alternate days, half the depreciation, which is otherwise allowable, will be actually allowed. He has started using the car immediately after purchase.

Determine the depreciation allowable on car for the A.Y. 2026-27, if this is the only asset in the block. If this car would also be used in the subsequent Assessment Year 2027-28 on the same terms and conditions above, what will be the depreciation allowable? Assume that there is no change in the legal position under the Income-tax Act, 1961.

The following additional information is provided by him:

- Closing stock of previous year 2025-26 was undervalued by ₹ 55,000.
- Rates and taxes include ₹ 1,000 paid towards late filing of his Income-tax return for Assessment Year 2025-26 under section 234F of income - tax Act.
- Salaries include ₹ 30,000 paid on single day by way of cash to his accountant.
- Interest paid on loan of ₹ 10,00,000 taken from a Non-Banking Finance company. Out of the loan, amount of ₹ 2 lakhs were used for personal purpose and the balance was used for business purpose. No TDS was deducted while paying the interest on loan.
- General expenses include Advertisement expense of ₹ 25,000 paid by cheque towards an advertisement in a souvenir published by local political party.
- Income-tax refund includes ₹ 2,500 towards interest.
- Depreciation charged is as per Income-tax Rules is ₹ 2,20,000
- TDS has been deducted on interest received on FD.
- Turnover for the year ending 31.03.2025 was ₹ 2.58 crores.
