→ Planning: Management accounting helps to plan various things for making decision and it plans for the future of the organization.

Supplying Information to Various Levels of Management: Every level of management requires information for decision-making and policy execution. 2) Resource Utilization: It is the key objective. It concerns with optimum utilization of available resources & limited resources to create maximum possible output.

Operations management is concerned essentially with the utilization of resources, i.e., obtaining maximum effect from resources or maintaining full use of resources available. The extent of the utilization of the resources potential might be expressed in terms of the proportion of resources consumed or occupied, space utilization, levels of activity, etc.
