It means that express mention of one thing excludes the other.
In a statute, where things are specified in a list, it means all other things are excluded from it.
This is usually indicated by "includes" or "such as".
The rule is also known as the negative implication rule.

1.5 Marks

This is a statute granting certain rights to "police, fire, and sanitation employees" would be interpreted to exclude other public employees not enumerated in the legislation. This is based on presumed legislative intent and where for some reason this intent cannot be reasonably inferred the Court is free to draw a different conclusion.
The general meaning of "expression of one thing is the exclusion of another" is also known as the negative implication rule. This rule assumes that the legislature intentionally specified one set of criteria as opposed to the other. Therefore, if the issue to be decided addresses an item not specifically named in the statute, it must be assumed the statute does not apply.

The Public Interest Litigation (PIL) of X, an employee of BG Ltd. regarding shifting of registered office is not tenable.

By doing so, it will affect BG's revenue and loss will have to be paid.
BG's Revenue Court held that loss of revenue will be an economic loss. A state can not protect company's revenue.

Here X, argue that Company's business will be affected, but Registrar office shifting is a decision of Board and they must have considered all facts along with their own discretion to change office to ensure better company performance to change office.
